**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

This has been on-going for a # of years and will continue with Contracts that require vacancy to perform. If an Emergency Grant to replace sewer lines under the Cayman Buildings (see below) is approved we will ask to take 6 units off-line for 15 month to use in Relocation Activities/</p> <p>We have applied for and been approved for two Emergency Grants (Jonesboro &amp; Imboden) to replace outside sewer lines; Jonesboro is complete and Imboden ongoing. We have applied and received a CFP Emergency Safety Grant to install CO/Smoke Detectors in the JURHA and Imboden units that has gas to heat, this grant has been completed and closed out. We are in the process of applying for another Emergency Grant replace the sewer lines under the Cayman Villa buildings. Another Emergency Security and Safety Grant is pending to install grounds security cameras at our Jonesboro developments.</p>

Describe fair housing strategies and actions to achieve the goal

Since August 11, 2017 JURHA broadcasts the HUD Fair Housing Channel in the lobby when we are open. JURHA also makes available the following brochures to applicants and participants: Fair Housing Brochure (English and Spanish), Are You a Victim of Fair Housing Complaint form (English and Spanish), Notice of Occupancy Rights Under the Violence Against Women Act & Certification of Domestic Violence, Dating Violence, Sexual Assault, or Stalking and Alternate Documentation, and Legal Aid of Arkansas Brochures (English and Spanish) A Fair Housing Guide for: Persons with Disabilities, Sex Discrimination, Domestic Violence, & religious Discrimination.

JURHA has added a Fair Housing tab to our website at [www.jurha.org](http://www.jurha.org) and linked a YouTube presentation from Legal Aid called “Navigating the Fair Housing Act by Legal Aid of Arkansas”. The presentation is also available in a written format on the website.

Describe fair housing strategies and actions to achieve the goal

JURHA entered into a Memorandum of understanding to “affirmatively further fair housing” on Mary 17, 2018. We continue our partnership by participating in an annual fair housing training for JURHA staff. We have also collaborated to provide landlord fair housing training and published a YouTube fair housing for tenants on the JURHA website.

JURHA has been an associated member of the Northeast Arkansas Landlord Association since 2017. Meetings resumed in 2023. The HCV Administrator attends most meeting and Provides updates on HQS/NSIRE, Payment standards, and answers questions from landlords

**Fair Housing Goal #4: JURHA representative will attend monthly meetings with property owners to promote and educate property managers especially owners with properties in high opportunity areas to participate in the Housing Choice Voucher Program. Enlist 10 new owner’s annually.**

**JURHA began measuring this goal April 1, 2017.**

**39 new owners were added from April 1, 2017 – March 31, 2018.**

**32 new owners were added from April 1, 2018 – March 31, 2019.**

**39 new owners were added from April 1, 2019 – March 31, 2020.**

**42 new owners were added from April 1, 2020 – March 31, 2021.**

**53 new owners were added from April 1, 2021– March 31, 2022.**

- C.1 Resident Advisory Board (RAB) comments.** If the RAB had comments on the annual plan, mark "yes," submit the comments as an attachment to the Plan and describe the analysis of the comments and the PHA's decision made on these recommendations. (24 CFR §903.13(c), 24 CFR §903.19)

Form HUD-50077-ST-HCV-HP, *PHA Certifications of Compliance with PHA Plan, Civil Rights, and Related Laws and Regulations Including PHA Plan Elements that Have Changed* must be submitted by the PHA as an electronic attachment to the PHA Plan. This includes all certifications relating to Civil Rights and related regulations. A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).
- C.4 Challenged Elements.** If any element of the Annual PHA Plan or 5-Year PHA Plan is challenged, a PHA must include such information as an attachment to the Annual PHA Plan or 5-Year PHA Plan with a description of any challenges to Plan elements, the source of the challenge, and the PHA's response to the public.

**D. Affirmatively Furthering Fair Housing.**

**D.1 Affirmatively Furthering Fair Housing.**

The PHA will use the answer blocks in item D.1 to provide a statement of its strategies and actions to implement each fair housing goal outlined in its accepted Assessment of Fair Housing (AFH) consistent with 24 CFR § 5.154(d)(5) that states, in relevant part: "To implement goals and priorities in an AFH, strategies and actions shall be included in program participants' ... PHA Plans (including any plans incorporated therein) .... Strategies and actions must affirmatively further fair housing ...." Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
